Dit is ooreengekom dat vanweé die vandalisme van die sportfasiliteit in Umzamowethu, so 'n fasiliteit nie in Oesterbaai aangewese is nie. Dit is ook 'n laer prioriteit op die Munisipaliteit se agenda.</p> <p>5.2 TELKOMPALLE Op versoek van Ben Schellingerhoudt het Walter e-posse en WhatsApp boodskappe aan Telkom gestuur. Die reaksie was teleurstellend, aangesien Telkom vir elke erf waar 'n probleem bestaan, 'n aparte aanmelding verwag. Die pale en drade waaroor gekla is, is verwyder, maar vanweé die omvang indien elke erf afsonderlik aangemeld moet word, word voorgestel dat elke eienaar lastige en gevaaiklik drade moet knip.</p>	<p>1. OPENING Prof. Tolmay opened the meeting with a prayer.</p> <p>2. WELCOME Walter welcomed all residents and visitors present. Johan Jacobs requested that the meeting be dedicated to the late Joe Meyer due to his legacy in Oyster Bay.</p> <p>3. APOLOGIES Krisjan Korf, Elize Knoetse, Kotie and Angelique Sevenster, Buks and Maranda Degenaar, Peter Freemantle.</p> <p>4. ACCEPTANCE OF MINUTES AGM 2021 The minutes of the AGM 2021 had been sent to all members per WhatsApp and were posted on the Oesterbaai.info website. The minutes were accepted. Proposed by: Johan Jacobs Seconded by: Adriaan van Wyk</p> <p>5. MATTERS FROM PREVIOUS MINUTES</p> <p>5.1 SPORT FACILITIES Management deliberated the matter. It was agreed that due to the vandalizing of the sport facilities in Umzamowethu, sport facilities will not be feasible in Oyster Bay. It is also a lower priority for the Municipality.</p> <p>5.2 TELKOM POLES In reaction to a request by Ben Schellingerhoudt, Walter sent emails and WhatsApp messages to Telkom. The response was disappointing. Telkom expected a separate reporting for each plot where problems exist. The poles and wires complained about, was removed. Due to the extent of the problems which now necessitate separate requests, Walter proposed that each owner cut hazardous wires.</p>

Behalwe vir die verlies van 'n vriend, is sy toewyding tot die verbetering van Oesterbaai onvervangbaar.</p> <p>6.1 FINANSIES</p> <p>Martiens bespreek die aangehegte finansiële state.</p> <p>Hy som op deur te sê dat in 2022 meer gedoen is met minder geld.</p> <p>6.2 OMGEWINGSAKE</p> <p>Die Munisipaliteit gaan voort met die rehabilitasie plan van die duine waarmee hulle en Joe Meyer besig was. Otto, Buks en Walter probeer instaan. Walter herinner die vergadering net weer dat die werk met byna 'n jaar vertraag is, vanweë die klage wat aan die Munisipaliteit gerig is. Dit het daartoe gelei dat Omgewingsake en Kusbestuur weereens moes ondersoek instel en die aanvanklike plan moes goedkeur.</p> <p>Die OIV het sedert die aanvang van die duinrehabilitasie projek, R1.4 miljoen daaraan spandeer en die Munisipaliteit R20 miljoen.</p> <p>Johan Bouwer bedank die Bestuur vir hulle harde werk. Hy is van mening dat dit belangrik is om iemand op die Bestuur te kry, wat kennis van die bestuur van duine het.</p> <p>Walter meld dat slegs R900 000 begroot is vir die duine vir dié finansiële jaar. Hy meld verder dat daar 'n goeie verhouding bestaan met Proporsionele Raadslid Shena Ruth. Johan kan haar ook kontak.</p> <p>Prof. Tolmay wat 'n eiendom in Branderstraat het meld dat hy 'n omgewingskundige genader het. CHAIRMAN'S REPORT 2021</p> <p>Walter thanked Mias Strydom again for the free utilization of his Website and his diligent placement of all OBRA documents. The report is available on the website. The most important matters were discussed. Questions welcome.</p> <p>The passing away of Joe Meyer is a huge blow to Oyster Bay. He was a friend to many. His devotion to the improvement of Oyster Bay will not easily be replaced.</p> <p>6.1 FINANCE</p> <p>Martiens discussed the attached financial statements.</p> <p>In conclusion he stated that during 2022 more has been done with less money.</p> <p>6.2 ENVIRONMENTAL MATTERS</p> <p>The Municipality continues with the rehabilitation plan of the dunes which Joe and them were busy with. Otto, Buks and Walter endeavor to assist. Walter reminded the meeting that the work was delayed with nearly a year, due to the complaint to the Municipality. It resulted in re-evaluation of the rehabilitation plan by Environmental Matters and Coastal Management, which was ultimately again approved.</p> <p>Since the commencement or the dune rehabilitation project, OBRA spent R1.4 million and the Municipality R20 Million.</p> <p>Johan Bouwer thanked Management for their hard work. He is of the opinion that it is important to get a person on the Management Committee with knowledge of dune management</p> <p>Walter mentioned that only R900 000 was budgeted for the dune rehabilitation this financial year. He also mentioned that a good relationship exists with Proportional Cllr. Shena Ruth and that Johan may contact her.</p> <p>Prof. Tolmay, who has property in Brander Street, mentioned that he was in contact with an environmental expert. He requested that the dunes continuously be critically evaluated, because flattening of the dunes on one side</p>

The Municipality must accept the responsibility.</p> <p>Jaco Marx mentioned that the braai structure at the beach has been broken down and the bricks left there. It creates a bad image to visitors.</p>
<p>6.3 WATERVOORSIENING</p> <p>Walter noem dat ten spye van beurtkrag, gaan dit goed met Oesterbaai se watervoorsiening. Hy bedank Otto en Buks vir hulle oorsig.</p> <p>Otto noem dat die sonpanele vir die pompe te swak is en dat 'n generator benodig word. Wanneer Eskom krag nie beskikbaar is nie, sal dit ly tot geen watervoorsiening nie. Die koste daaraan om 'n generator aan te koop beloop R200 000. Borge sal hiervoor benodig word.</p>	<p>6.3 WATER SUPPLY</p> <p>Walter informed the meeting that, in spite of load shedding, the water supply in Oyster Bay is good. He thanked Otto and Buks for their continuous monitoring.</p> <p>Otto mentioned that the solar panels for the water pumps are inadequate and that a generator is needed. When Eskom electricity is down, it will result in no water supply. The cost for a generator will be R200 000. Sponsors will be needed for this.</p>
<p>6.4 GEMEENSKAPSAAL</p> <p>Walter bedank Adriaan vir die bestuur van die saal, asook al die bestuurslede wat behulpsaam is met die oop- en toesluit van die saal.</p> <p>Walter benadruk dat die verf van die dak van die saal 'n groot prioriteit is. 'n Kwotasie is van Eco-rubber bekom en aan die Munisipaliteit voorsien. Die Bestuur het R40 000 aan die Munisipaliteit vir die doel goedgekeur, indien die Munisipaliteit die verf ten bedrae van R90 000 sal betaal.</p> <p>Walter verwys die vergadering na die Voorsitter verslag vir verdere inligting.</p>	<p>6.4 COMMUNITY HALL</p> <p>Walter thanked Adriaan for the management of the hall. He also thanked all the members of the Management Committee for their assistance with the locking and unlocking of the hall.</p> <p>Walter emphasized that the painting of the roof of the hall is a priority. A quotation was obtained from Eco-rubber and submitted to the Municipality. Management approved R40 000 for this purpose, with the proviso that the Municipality pay for the paint to the amount of R90 000.</p> <p>Walter referred the meeting to the Chairman's report for further information.</p>

He thanked Buks for the hard work to maintain the internal roads and his continuous negotiations with the Municipality for gravel and tar. The Provincial road is graded twice per year. Residents had a difficult time with the condition of the road since June. He mentions that R4 mil. Is budgeted for the bridge.</p>

Na verdere bespreking meld Walter dat slegs gemagtigde beampies wat as vrederegters opleiding gehad het, persone wat op die strand ry mag aanspreek. Vrederegters word deur die Munisipaliteit aangestel. Hy versoek dat foto's van diesulkes geneem word en aan die Munisipaliteit op die WhatsApp kliëntediens nommer rapporteer word.</p>	<p>7 NEW MATTERS</p> <p>7.1 QUAD BIKES</p> <p>Kobus de Meyer requested that another notice board be erected at the entrance to the beach after the single incident where quad bikes were driven on the large dune. After further discussion, Walter mentioned that only authorised officials who received training as peace officers may address people driving on the beach. Peace officers are appointed by the Municipality. He requested that the trespassers be reported on the Municipality client services WhatsApp number, together with photos of the vehicles.</p>
