1. VERKIESING VAN KOMITEELEDE

2. GEMEENSKAPSAAL

Daar word beplan om 'n naambord by die gemeenskapsaal aan te bring. Projek is oorgedra na 2017.

Die klankstelsel is verouderd en nie meer in werkende toestand nie. Finale besluit hieroor sal in 2017 geneem word.

Die toilette is geseel en in goeie toestand.

Die geute wat vervang moet word geniet aandag van die Munisipaliteit.

Daar is ook besluit om van die foutiewe projektorskerm en yskas ontslae te raak.

'n Versoek is ook aan die Munisipaliteit gerig dat die OIV weer die gebruik van een van die twee kantore wat tans deur die Raadslid beset word, terugkry. Raadslid geregtig op slegs een kantoor. 'n Besluit hieroor sal vroeg in 2017 geskied.

3. AFVALSTORTINGSTERREIN

Uiteindelik gaan daar ook hier iets gebeur. Daar is 'n begroting goedgekeur van R250 000 vir die verbetering van die huidige terrein. Na verskeie besoeke aan die terrein is daar ooreengekom dat dit nie verskuif kan word nie. Die begroting is geallokeer vir die tydperk 1 Julie 2016 tot 30 Junie 2017. 1. ELECTION OF COMMITTEE MEMBERS

Most of the current committee members have come to the end of their service period. New members must be elected/ service periods extended.

2. COMMUNITY HALL

It is envisioned to put up a namebord at the Community Hall. Project carried over to 2017.

The sound system is out-dated and not in working order. Final decision to be taken in 2017.

Toilets are sealed and in good condition.

Maintenance receives attention from the Kouga Municipality.

The faulty projector and fridge will be disposed of.

Requests for the use of one of the two offices currently in use by the Ward Counsellor are made. Councillors only granted the use of one office. Decision should be taken early 2017.

3. REFUGE DUMP SITE

At last something is happening. A budget of R350 000 was approved for the improvement of the existing terrain. After numerous visits to the site, it has been decided that it is not possible to move the site. The budget is allocated for the period 1 July 2016 to 30 June 2017. Should additional funds be needed, it could be requested in February 2017. After completion the site would consist of:

5. OMGEWINGSBESTUURSPLAN

Joe Meyer en sy span het baie hard gewerk. In Oesterbaai is daar 'n nuwe gees van optimisme met al die herstelwerk wat plaasgevind het. 'n Volledige verslag sal tydens die Algemene Jaarvergadering op 22 Desember 2016 ingedien word. The site has been clean and a skip is placed for domestic waste and a site identified for garden refuge. Please make sure to dump in designated areas and thus assist in the management of the site.

4. ROADS

Joe and his team worked very hard to maintain the roads in Oyster Bay and Umzamowethu. Lexinton's also participate in this initiative.

5. ENVIRONMENTAL MANAGEMENT PLAN

Joe Meyer and his team worked very hard. In Oyster Bay a new optimism is visible. A full report will be available at the Annual General Meeting on 22 December 2016. As always financing remains problematic and therefore we once again appeal to everyone (residents, holiday makers, etc.) to give generously for this cause. A new borehole enhances the water availability in Oyster Bay. The new borehole has a capacity of around 5000l/hour. The reservoir is repaired and sealed. Maintenance was also done on other boreholes. The holiday season always increase usage of water facilities and we therefore request that water be used sparingly. Kouga Municipality imposes stringent water restriction. . The Committee therefore still recommend that all property owners invest in 5000 litre water tanks with a suitable pressure pump to assist should any water crisis developed. South Africa currently experience serious drought conditions.

13. FIRE WORKS

Fireworks are prohibited in Oyster Bay and the beach area. No person may use or discharge any fireworks unless he or she is in possession of a permit authorising such use, issued by an inspector in the manner prescribed by the Explosives Act (Act 15 of 2003). The use of paper lanterns are strongly disapproved by the Commander of Station 36 of the NSRI and the Fire Brigade. NSRI is inundated by calls misinterpreting the lanterns as stress signals. 14. DOGS ON THE BEACH

For most of Oyster Bay people our dogs are very important and we would like them not to be banned from the beach as has already happened on some other beaches.
